OUR WORK

Whether in the United States or abroad, our programs focus on the pursuit of justice.

TEACHING HUMAN RIGHTS

Our human rights education program, Speak Truth to Power, strives to create a global citizenry through classroom education. We develop student lesson plans in collaboration with educators that bring the stories of human rights defenders to life. Students gain an understanding of pressing human rights issues, and build hands-on activism experience through activities that encourage direct engagement with decision-makers in their localities.

ENGAGING THE INVESTMENT COMMUNITY

Robert F. Kennedy Human Rights holds annual conferences to help decision makers at public and corporate pension funds, endowments, foundations, sovereign wealth funds, and family offices fulfill their fiduciary duties and meet the challenges of investing. Our Robert F. Kennedy Compass Conference series gathers over 150 institutional investors and asset managers who oversee more than \$7 trillion in collective assets to discuss the role of long-term asset ownership and ways to deliver superior risk-adjusted returns while considering human and labor rights, corporate governance, and the environment.

ADVOCACY AND LITIGATION

Robert F. Kennedy pledged that “those with the courage to enter moral conflict will find themselves with companions in every corner of the globe.” Our team of lawyers and issue experts collaborate with partners around the world to create lasting legal change. Through legal advocacy, we have freed political prisoners, defended the rule of law in autocratic regimes and amplified the voices of human rights defenders in the United States and abroad.

INSPIRING YOUNG LEADERS

Robert F. Kennedy called young people “the world’s hope.” We foster that optimism by convening young leaders engaged in making their world a more just and fair place. These innovative, influential and philanthropic young adults host events and share ideas that result in new approaches to human rights advocacy.

THE ROBERT F. KENNEDY LEGACY

Arthur Schlesinger, Jr. called him “the most creative man in American public life.” Ronald Reagan said, “He aroused the comfortable. He exposed the corrupt, remembered the forgotten, inspired his countrymen, and renewed and enriched the American conscience.” We honor Robert F. Kennedy’s legacy by continuing his efforts towards a more just and peaceful world, and by introducing his life and inspiring new generations to make a difference.

2017 YEAR IN REVIEW

INTERNATIONAL ADVOCACY AND LITIGATION

Fought arbitrary detention in Egypt:

- In April, we welcomed home our clients Aya Hijazi and Mohamed Hassanein, co-founders of the Belady (“My Country”) Foundation, after three years of being unlawfully detained in Egypt.

Fought to protect freedom of expression in Colombia, Egypt, and Uganda:

- We presented oral arguments before the Inter-American Court of Human Rights in representation of the family of Nelson Carvajal, a journalist murdered in Colombia.
- We filed a petition before the UN Working Group on Arbitrary Detention on behalf of Mahmoud Hussein, a prominent Al Jazeera journalist unlawfully detained without charge and subjected to severe mistreatment by the government.
- Received a landmark decision from the UN Working Group on Arbitrary Detention in the case of Ugandan human rights defender, Stella Nyanzi, for the first time addressing a government’s abuse of cyber crimes laws to silence dissent.

Sought accountability for crimes against humanity in North Korea:

- Staging a session on crimes against humanity in political hearings in North Korea

Supporting 2014 RFK Human Rights Laureate, Adilur Rahman Khan, against the government’s

- Attempts to silence him through baseless criminal charges in Bangladesh

Conducted High-Level Advocacy Mission to Mexico:

- In October, a delegation from RFKHR traveled to Mexico on an advocacy mission to raise awareness on human rights violations in the country, including violence against women, extrajudicial killings, and forced disappearances.

Fought against discrimination and violence against LGBT people in Honduras:

- We filed a precedent-setting merits brief in a case involving the State’s failure to address violence against transgender women in Honduras

Furthered continent-wide standards to protect civic space in Africa

- Leading UN expert Maina Kiai joined as amicus curiae in our case to protect the independence of civil society organizations in Rwanda and rights to engage peaceful protests in Zimbabwe, detailing standards that have the potential to raise continent-wide civic space protections.

Created exchange opportunities among human rights defenders from Latin America and Africa to protect civic space:

- Human rights experts identified challenges and responses to the closing of civic space in both regions

Denounced denationalization of Dominicans of Haitian Descent:

- Launch of a report that analyzed the Dominican Republic’s history of denationalization policies against Dominicans of Haitian descent

2017 RFK Human Rights Award:

- We awarded our 2017 Human Rights Award to prominent human rights activist Alfredo Romero for his work against arbitrary detention and State repression in Venezuela.



U.S. ADVOCACY & LITIGATION

Launched program focused on criminal justice reform & reducing pretrial incarceration:

- With the generous support of the Fund II Foundation, we launched our criminal justice reform program in 2017. The program targets pretrial detention as the front door to mass incarceration in the United States through legal intervention, social mobilization, and industry disruption.

Reforming New York's criminal legal system

- In partnership with community-based organizations like 2016 Human Rights Award Laureate JustLeadershipUSA, we advocated for crucial legislative reform in Albany and rallied for the #CLOSErikers campaign.
- With the Katal Center for Health for Health, Equity, and Justice we convened an expert working group and organized 100 organizations from across the state of New York to sign on to a progressive framework for bail reform in Albany. The coming together of these organizations was unprecedented and came a critical time where the momentum in Albany was trending toward possible backwards developments under the guise of "reform."

Our Youth belong in #ClassroomsNotCages

- In August 2017, Robert F. Kennedy Young Leaders supported Robert F. Kennedy Human Rights, Fund II Foundation, Youth Represent, the Bronx Freedom Fund and the Brooklyn Community Bail Fund in #ClassroomsNotCages, a digital fundraising and social media campaign aiming to reduce New York's population of incarcerated high-schoolers by paying their bails. #ClassroomsNotCages constitutes Robert F. Kennedy Young Leaders' first foray into digital fundraising and social media-driven campaigning, and it exceeded all expectations. In just two weeks, #ClassroomsNotCages raised \$103,252.45, including contributions from over 200 first-time donors. To date, that money has already been used to bail out over 50 high-school-aged New Yorkers.

Tactical Bail Outs to Create Advocacy Moments and Raise Public Awareness

- Posted \$100,000 bail for Pedro Hernandez, an innocent 17 year old unjustly detained pre-trial in Rikers Island for over a year, and leveraged the widespread media and public attention to create a powerful advocacy moment for bail reform across New York.

Harnessing technology to disrupt the broken justice system

- Millions of people are jailed every year because they miss court. A failure to appear results in incarceration that can be avoided 99% of the time. Uptrust sends text message reminders to people about court dates and other obligations. This simple SMS technology serves to modernize the criminal legal system, and substantially reduce the number of people unnecessarily incarcerated. Over the past six months, RFKHR has been working with Uptrust and the Baltimore Public Defender's Office in Maryland to introduce the use of Uptrust for all of their clients. The technology is now in place, and will be rolled out in January 2018. The system will reach over 2,000 clients per month, and will reduce the number of people held in pretrial detention in Baltimore.

Tactical Bail Outs to Create Advocacy Moments and Raise Public Awareness

- Posted \$100,000 bail for Pedro Hernandez, an innocent 17 year old unjustly detained pre-trial in Rikers Island for over a year, and leveraged the widespread media and public attention to create a powerful advocacy moment for bail reform across New York.

Launched a Campaign to Bail Out High School Aged New Yorkers

- Launched the #ClassroomsNotCages Campaign, raising over \$100,000 and posting bail for almost 70 high schoolers who were being detained pre-trial in Rikers Island.

Advocated for Statewide Legislative Reform in Albany:

- Worked with partners across New York State to meaningfully advance gold-standard legislation to end money bail and reform the criminal legal system in the NY State Assembly and Senate.

INSPIRING YOUNG LEADERS

Robert F. Kennedy Young Leaders Speaker Series

The recurring Robert F. Kennedy Young Leaders Speakers Series features top young activists who are leading the fight for human rights and creating change in innovative, impactful ways. To date, our Speakers Series has educated and mobilized over 1,000 young New Yorkers on today's most pressing issues.

In 2017, that series included an appearance by Insha Rahman of the Vera Institute, who is collecting data to help drive criminal justice reform across New York state. Rahman spoke on the poverty-criminalizing nature of money bail, the relationship between average bail amounts in America and average household income, and her background as a Public Defender.

Dollar Bail Brigade

In 2017, Robert F. Kennedy Young Leaders partnered with the Bronx Freedom Fund to launch Dollar Bail Brigade, a service wherein volunteers pay their fellow New Yorker's \$1 bails, in person at local jails. Since our kick-off event in June, Dollar Bail Brigade's membership has grown to over 600, with monthly volunteer schedules full of new and veteran Brigaders. To date, the Dollar Bail Brigade has freed over 80 New Yorkers being detained on a one dollar bail.


